- The Green Deal is a big policy package of various different policies that interconnect
- Climate change and environmental degradation are an existential threat to Europe and the world. To overcome these challenges, Europe needs a new growth strategy that will transform the Union into a modern, resource-efficient and competitive economy, where
  - there are no net emissions of greenhouse gases by 2050
  - economic growth is decoupled from resource use
  - no person and no place is left behind
- The European Green Deal is a plan to make the EU's economy sustainable.
- We can do this by turning climate and environmental challenges into opportunities, and making the transition just and inclusive for all.

- European Green Deal provides an action plan to
  - boost the efficient use of resources by moving to a clean, circular economy
  - restore biodiversity and cut pollution

- European Climate Law to turn this political commitment into a legal obligation



- Reaching this target will require action by all sectors of our economy, including
  - investing in environmentally-friendly technologies
  - supporting industry to innovate
  - rolling out cleaner, cheaper and healthier forms of private and public transport
  - decarbonising the energy sector
  - ensuring buildings are more energy efficient
  - working with international partners to improve global environmental standards
- The EU will also provide financial support and technical assistance to help those that are most affected by the move towards the green economy
- This is called the Just Transition Mechanism
- It will help mobilise at least €100 billion over the period 2021-2027 in the most affected regions



#### **Climate Action**

- European 'Climate Law'
  - 2030 intermediate target
  - 2050 climate neutrality objective into legislation, strengthening the framework for ambitious climate action
- EU Strategy on Climate Adaptation

#### **EU Climate law**

- Regulation (EU) 2021/1119 establishing the framework for achieving climate neutrality and amending Regulations (EC) No 401/2009 and (EU) 2018/1999
- intermediate target of reducing net greenhouse gas emissions by at least 55% by 2030, compared to 1990 levels
- a legal objective for the Union to reach climate neutrality by 2050
- 2030 climate target of at least 55% reduction of net emissions of greenhouse gases as compared to 1990, with clarity
  on the contribution of emission reductions and removals
- EU's carbon sink through land use, land-use change and forestry (LULUCF regulation)
- process for setting a 2040 climate target, taking into account an indicative greenhouse gas budget for 2030-2050
- negative emissions after 2050
- European Scientific Advisory Board on Climate Change
- provisions on adaptation to climate change
- coherence across Union policies with the climate neutrality objective
- sector-specific roadmaps charting the path to climate neutrality in different areas of the economy



## **EU Adaptation Strategy**

#### **Ozone Regulation**

- legal basis for the protection of the ozone layer.
- Regulation (EC) 1005/2009 on substances that deplete the ozone layer

  - Obligations of the Montreal Protocol on substances that deplete the ozone layer
  - Ensure a higher level of ambition in the EU than required by the Protocol, in areas where this is technically and economically feasible




